THE CHALLENGE

Prior to SHEQX®, Interwaste relied on fragmented systems for incident reporting, document control, inspections, and SHEQ-related communication. Processes were often site-specific and required manual consolidation of spreadsheets, emails, and disparate documentation. This created delays in risk visibility and hindered timely, informed decision-making at an operational and executive level.
